What information does CreditBox collect?

How does CreditBox use your information?

- CreditBox may share your non-personal and personal information described above from time to time with Non-Affiliates pursuant to a Joint Marketing Agreement (as defined below).
- CreditBox may share your non-personal and personal information described above from time to time with CreditBox's Affiliates for CreditBox's Affiliates' everyday business purposes and marketing purposes.
- CreditBox may share your non-personal and personal information described above from time to time with Non-Affiliates so that they can market services and products to you.
- CreditBox may share your non-personal information described above from time to time with Non-Affiliates so that they can enable CreditBox to verify your identity by registering and remembering devices associated with your account for purposes of fraud detection and prevention.

If you are an existing or former customer, CreditBox can continue to share your information as described in this Privacy Policy. Please note that regardless of whether you are a new, existing, or former customer, at any time you can limit CreditBox's sharing of your information by following the instructions set forth above in the section entitled "How can you limit sharing of your personal information?"
